TEMISKAMING SHORES - As of noon July 6, Temiskaming's last active COVID-19 case number 208 - was deemed resolved almost one month ago.

While there's virus activity to the north in the Porcupine Health Unit and to the south in the North Bay area, "we're still at zero cases," said Temiskaming's acting medical officer of health earlier this week.

But given the presence of the more infectious Delta variant in Ontario, "we need dual vaccination to give best protection," said Dr. Glenn Corneil in a phone interview July 5.

There has been progress on the vaccination front, and some changes coming as to when

SECOND DOSE

As of July 5, anyone aged 12 and up can book a second dose 28 days after their first.

And because of that timing, ample supplies of vaccine and the Delta variant, the health unit has cancelled its previously scheduled second-dose clinics beginning the week of July 19.

It is instead encouraging people to book new appointments now.

The original bookings were made when vaccine supply was limited.

But that's no longer the case, said Corneil.

unit, at 1-866-747-4305 ext. 6 if online service is not an option.

"There's robust vaccine supply and openings right now," he said.

Beginning next week, he said it's moving to the walk-in clinic model "to make it as flexible as possible for people."

The mass immunization clinics themselves will be coming to an end.

When precisely they'll be shut down has not yet been determined, he said.

But he said the arenas will be needed when hockey and figure skating resume. It's also a challenge to staff them as client numbers drop, he said. First and second doses are

Corneil said there's a misconception that pharmacies offer only the AstraZeneca vaccine. In fact, he said mRNA vaccines - Pfizer and/or Moderna - are available.

NUMBERS

As of late last week, almost 78 per cent of Temiskaming adults aged 18 and up had received a first dose, and 56 per cent a second.

Corneil was pleased to see that the uptake among young-

But uptake remains lower among the youngest members of the eligible population - 56 per cent of the 12-to-17 age group have received a first dose, and almost 59 per cent of the 18-29 population.

When it comes to the 12to-17 group, the health unit is encouraging them to be fully vaccinated with two doses by August 22. That means they should receive their first dose

Charges laid in fatal Hwy. 11 crash

CHAMBERLAIN (Staff) - An Englehart resident is dead and a Sesekinika resident has been charged following a fatal collision north of Englehart last week.

Christopher Martel, 49, was pronounced dead at the scene of a two-vehicle crash on Highway 11 in Chamberlain Township June 30.

Temiskaming OPP, the OPP canine unit and emergency response team, the Englehart fire department, and paramedics responded shortly after 7 a.m.

Temiskaming OPP say Martel had been driving the northbound vehicle.

Police say the driver of the southbound vehicle fled the scene on foot immediately after the collision. An individual was located a short time later in a wooded area by the canine unit and emergency response team and arrested.

A 42-year-old resident of Sesekinika has been charged with dangerous operation causing death; failure to stop after accident; and failure to comply with a probation order.

The OPP's technical traffic collision investigators and the Office of the Chief Coroner-Ontario Forensic Pathology Service are assisting with the investigation.

Highway 11 was closed for about nine hours.

Detours were established along highways 560, 65 and 66.

The highway reopened shortly before 4 p.m.

Police say the investigation is ongoing.
