# ∞ **D** OPINION **EDITORIAL OUR POLITICIANS** MUST LEAD CITY OUT **OF OPIOID CRISIS**

Barrie is in the clutches of a public health crisis that demands an immediate, forceful reaction to match the intensity of its destruction.

We've watched, waited and reported as our city leaders have debated and discussed opioid addiction, only to find ourselves no further ahead and with no plan in sight.

It's not good enough.

Our community wants and deserves more, so we, as a local business, are stepping up today to do more.

In this issue of The Barrie Advance, we have dedicated every story to this crisis. We've provided a barrage of voices from those entrenched in this crisis with a goal to promote understanding and compassion, and to impact change.

Thinking of where Barrie will be next year if we do nothing now is more frightful than admitting we need help.

Council's lack of leadership has led to NIMBYism and a city divided, when it should have resulted in a coming together of hearts and minds.

We know methadone, which is used as a substitute drug in the treatment of opioid addiction, is dispensed at clinics throughout our city. Opioid addiction is not a downtown issue; it is a city-wide crisis.

Let's unite with parents who have lost children to addiction, spouses who have lost partners, and children who have lost parents to attack this crisis with a single focus: we won't lose anyone else.

Opioid addiction is not an issue about "them"; it is an issue about us.

Many can play a role in finding a solution, from the federal government, which regulates drug companies, to the province, which funds health care, but the fight has to start here at the municipal level.

Today, we are asking Mayor Jeff Lehman and all members of city council to declare a health crisis and to demand support from all levels of government to focus solely on the eradication of opioid addiction in Barrie.

Yes, it's a huge undertaking. Yes, many other cities and towns in Canada and across the U.S. are under siege by opioids. But they are not Barrie.

Our city's resumé is second to none. When we identify a lack of care in a specific area of health, we rally. We now have a highly regarded cancer centre, cardiac care closer to home and improved mental health services for our youths.


We can and have moved mountains. We can move this one. as well.
